# FY 2025 PROPOSED OPERATING & CAPITAL BUDGET COMMUNITY INPUT

## **EXECUTIVE SUMMARY**

The City of San Antonio, in partnership with each City Council District, hosted **ten in-person town halls** and **one youth townhall** between August 19 and August 31, 2024 to share information with the community on the Fiscal Year 2025 Proposed Budget. The town halls featured panels comprised of key City department leaders and were moderated by each Councilmember. The panels were tailored to suit the unique needs and priorities of each council district.

Budget town halls had an **average attendance of 64 people** at each of the eleven meetings – and received high marks from attendees, with approximately **93 percent providing positive or neutral feedback** regarding the meeting logistics and format. The town halls were available in English and offered Spanish and American Sign Language interpretation.

Residents provided a wide variety of comments that generally aligned with the priorities reflected in the Budget Survey:

#### 1. Infrastructure

 Residents had various infrastructure-related concerns, such as the prioritization of streets and sidewalks, street maintenance, code enforcement and lighting.

#### 2. Homelessness

- There is a concern about individuals who may have difficulty accessing shelters and getting off the streets, including into permanent supportive housing.
- Questions were asked about homeless encampment cleanups and their effectiveness.

#### 3. Public Safety (to include Mental Health)

- There is a strong desire for increased police presence.
- Concerns were expressed about issues such as mental health calls and the need for more active police engagement.

#### 4. Animal Care Services

- Residents expressed concerns related to animal welfare, including more spay / neuter clinics, issuing citations for dangerous dogs, and animal care officer response times.
- There were also requests for more spay / neuter clinics and improved enforcement of regulations.

#### 5. General Budget


 Questions were asked about the budget process, including how decisions are made regarding community needs and where residents can find more detailed information about the Proposed Budget.

## DISTRICT COLLABORATION

Communications & Engagement collaborated with each of the ten City of San Antonio Council Districts to select locations in their districts and promote the budget town halls. City Departments and Council offices promoted the town halls through social media, Nextdoor, eblasts, doorhangers and through their neighborhood leadership. In addition, Communications & Engagement coordinated with Council offices to:

- Post yard signs with budget participation information at field offices and at visible locations in each district, such as libraries and senior centers.
- Distribute flyers in English and Spanish.
- Select locations based on resilience hubs, such as neighborhood facilities or popular locations in each district.
- Select panel participants to highlight key service needs in each district.
- Customize formats, layouts, and panel questions to best serve each community.

Paid media about the Town Halls generated more than **1.6 million impressions**, earned media generated **\$425k** in value, social media posts reached hundreds of thousands of residents and generated more than **21,000 interactions**.

## SUMMARY OF QUESTIONS FROM TOWN HALLS



## SUMMARY OF EVENT FEEDBACK



#### Which Budget Town Hall did you attend?




#### Overall, how would you rate the Budget Town Hall?

### **Neighborhood Engagement Brief**

Communications & Engagement promoted the town halls through its Neighborhood Engagement Brief and in collaboration with neighborhood leaders. A summary of those efforts follows.

Approximately **2,065** resident subscribers throughout all ten City of San Antonio Council Districts were sent one email promoting the town halls. Email performance includes:

## EARNED MEDIA

Communications secured more than 5.5 **million earned media impressions** with a value of more than **\$425,000**.

## PAID ADVERTISING

Communications secured more than **1.6 million media impressions** through paid advertising.

Communications & Engagement leveraged street banners, sponsored social media content, streaming, audio, television, and digital video to promote the Fiscal Year 2025 Proposed Budget Town Halls in English and Spanish. To help address the digital divide and increase engagement with Districts 2, 3, 4, 5 and 6 street banners were placed in busy areas of each district.

Additional media buys were placed with Univision radio to engage Spanish-speaking residents. Nearly **18,000** emails written in Spanish were opened and the Spanish video produced by TVSA was viewed almost **85,000** times.

## DOOR HANGER DISTRIBUTION

**15,000** door hangers in English and Spanish were delivered in neighborhoods identified by the council districts. All door hangers included information on the upcoming town halls in their district and how to access more information by calling 311 or visiting SASpeakUp.com.

Districts were targeted based on engagement statistics from prior years.

My suggestion would be to not just talk about it but be about it. In other words, stop making promises. It was good that different departments of the city were there to represent but now it is time to do something about the various issues that is going on in the city.

This is a call for empathy and consideration, as it takes courage and conviction to address long-neglected problems without being passionate about promised solutions that have yet to occur. I believe Chief McManus was out of line to confront a citizen (by approaching the citizen with a hostile stance) who spoke about the police doing "nothing" about people experiencing homelessness. Chief McManus is an educated man who ought to have known that perhaps the proper word should have been "effective" in policing the homeless. Perhaps, Chief McManus failed to assess the speaker's clarity. Chief McManus ought to employ emotional intelligence on a matter that is burdensome to all its citizens. The citizen came to the meeting to address his concerns based on his perception of what the police were doing or not doing. Chief McManus should not view this as a personal attack on his department. Addressing community needs after decades of neglect compounded by

	increased population growth is very difficult. Wants and needs are indistinguishable and limited by budget constraints. This situation requires our collective action and understanding.
