2-1-1 Texas – Connecting People and Services



Collaborative Commission on Domestic Violence

n San Antonio, TX, the residents can call 2-1-1 to connect with services available within the local community. 2-1-1 Texas is a free anonymous social service hotline available 24 hours a day, 7 days a week, 365 days a year. Additionally, residents can call for services for family violence assistance. Family violence can incorporate violence against an intimate partner, former intimate partner, parent, sibling, child, extended family, or household member. Family violence can come in various forms from physical harm, bodily injury, the threat of harm causing fear of imminent danger, and emotional and mental harm.

The 2-1-1 family violence related calls for assistance include four major categories:

2-1-1 Texas – Connecting People and Services

he following table is а breakdown of the four major categories of calls to 2-1-1 for family violence assistance. In 2021, calls for Abuse Counseling, Sexual Assault Counseling, and Crisis Shelter have already exceeded the number of calls from 2020. This is indicative that residents are needing additional assistance within these areas. Additionally, there were several new assistance calls made within 2021 that were not previously noted in 2020. A few of the new requests are Abused Children, Abused Women, Crime Victim Compensation, and Crime Victim Safety Planning.

Bexar County Sheriff's Office

he Bexar County Sheriff's Office (BCSO) patrols 16 districts in unincorporated Bexar County. Within those 16 districts, the following information represents the number of Family Violence cases they handle. In 2020, BCSO saw a 4% increase in Family Violence cases:

however, BCSO has seen a decrease in family violence homicides. In August of 2021 BCSO in collaboration with STRAC began the use of a domestic violence hotline to evaluate victims for levels of lethality. This hotline has been able to not only identify high risk victims but allows for assisting victims with fleeing their homes or safety planning with victims. Of those screened 45% voluntarily left their residence to seek safety at either the Battered Women's Shelter, the Domestic Violence Hotel, or with Friends/Family.



Southwest Texas Regional Advisory Council

he Southwest Texas Regional Advisory Council (STRAC) is designated by the Texas Department of State Health Services (DSHS) to develop, implement, and maintain the regional trauma and emergency healthcare system for the 22 countries in Trauma Service Area – P (TSA-P). University Health (UH) graciously funded the innovative MEDCOM Domestic Violence Hotline through STRAC. STRAC is hosting the hotline via MEDCOM and ensuring the correspondence from law enforcement to victim advocacy is established upon identification of a high-risk lethality case. The hotline is a collaborative approach, involving UH, STRAC, BCSO, Family Violence Prevention Services, and City of San Antonio (COSA) Metro Health Violence Prevention, establishing innovative fundamentals regarding how to assist victims of domestic violence who are at high risk for lethality.

On August 9, 2021, UH, STRAC, BCSO, Family Violence Prevention Services, and Metro Health Violence Prevention began the use of the MEDCOM Domestic Violence Hotline. STRAC MEDCOM is contacted by a BCSO Deputy when a Deputy has identified a family violence case to administer the Danger Assessment for Law Enforcement (DA-LE). The DA-LE is a lethality assessment designed to assess the risk level a victim has for being killed by their intimate partner and provides a score of High, Medium, or Low risk; the Deputy can override the score to a high if needed based on the totality of the situation. The lethality assessment evaluates various risk factors to determine the probability of future violence escalating causing severe harm and/or death. The assessment is conducted via a 10-question screener conducted by the BCSO Deputy and provided to STRAC MEDCOM. If there is a high risk score it is recommended that the victim flee their residence and seek safety which begins the process of safety planning for a victim. A victim can seek safety at the Battered Women's Shelter, the DV Hotel, or with friend/family, any destination will be incorporated with safety planning. Follow up services are provided to the victim by BCSO Crime Victim Advocates, Family Violence Prevention Services, and/or Metro Health Violence Prevention advocates. There has been great success thus far with 45% of victims willing to flee their homes and seek safety.

he San Antonio Police Department (SAPD) protects and serves the residents of San Antonio, Texas. SAPD has a vast area to serve and a high volume of calls for service. As the data below illustrates, family violence is an area of crime experiencing an upward climb. Within the data below, there are two different aspects, "Calls" and "Reports". "Calls" are indicative of when SAPD is called out to provide service. "Reports" are those incidents where reports are officially filed as an offense. Not all calls will lead to a report filed. It should be noted that the data for 2021 is only reflective through September 2021.






SAPD FAMILY VIOLENCE REPORTS BY MONTH





2019 SAPD FAMILY VIPOLENCE REPORTS MAP BY ZIP


2019 SAPD Family Violence Reports per 1,000 population





2020 SAPD FAMILY VIPOLENCE REPORTS MAP BY ZIP



Texas RioGrande Legal Aid (TRLA)

exas Rio Grande Legal Aid provides free legal services to low-income people facing most forms of civil legal problems in 68 Texas counties, including Bexar County. TRLA's Domestic Violence and Family Law group provides assistance in divorce and custody cases and helps victims of family violence, sexual assault and stalking to obtain protective orders. The tables below display the number of domestic violence and family law applications that TRLA received from Bexar County residents from January 2020 – August 2021. Please note that due to capacity issues, TRLA implemented a screening process for family law applications in May 2021, so the demand for family law assistance in Bexar County after that date may be even higher than the following numbers reflect.

he Bexar County District Attorney's Office (DA) receives and processes all the criminal family violence cases that originate in Bexar County. The DA provided the following information to highlight the criminal family violence cases on which they have oversight. The DA also provided information on civil cases handled by the Protective Order Division, which is an on-site service provider at the Bexar County Family Justice Center. Although a number of private lawyers, legal aid agencies, and DV organizations seek civil orders of protection for family violence victims, a majority of these civil PO applications are filed by the DA on behalf of the State of Texas for the survivor's safety. The chart depicts the civil protective order lawsuits filed by the DA in Bexar County and their movement through the civil court system.



he Center for Health Care Services (CHCS), the local mental health authority for Bexar County, screens for domestic violence during child and adult assessments. The State requires the completion of an assessment to determine authorization for service as well as level of care for treatment through a centralized enrollment process for adults and children. During the Adult Needs and Strengths Assessment (ANSA) and/or Child and Adolescent Needs and Strengths (CANS) assessment process, if certain questions are answered a particular way that would implicate domestic violence is experienced or exists in the home, further questions related to domestic violence are triggered.





Report Counts by Quarter and Fiscal Year








